Removal of Climate Action Plans and Links from the National Park Service's Climate Friendly Parks Program Website

Removal of Climate Action Plans and Links from the National Park Service's Climate Friendly Parks Program Website

Overview

92 documents regarding national parks' response to climate change have been removed from the National Park Service (NPS) "Climate Friendly Parks Program" website. NPS is part of the Department of the Interior. To become a Climate Friendly Parks (CFP) member, parks are required to meet four milestones,¹ which include developing a baseline of greenhouse gas emissions for park operations and completing a park climate action plan. Links to the parks' action plan documents and to two webpages detailing aspects of two particular parks' plans have been removed from a list of the Program's member national parks. No public NPS Web archive has yet been identified, but instructions to email NPS for access to the parks' action plans have been added.

Description of Changes in Access

1. On December 7, 2017, all links were removed from a list of 97 member park names on the NPS "Climate Friendly Parks Program" webpage (see [December 6](#) version). The links previously led to documents and webpages describing what "parks are doing to respond to climate change and move park operations in a more sustainable direction" ([Page 1](#)).
2. By [December 20, 2017](#), 92 park climate action plan documents, corresponding to 92 of the 97 removed links, were removed from the NPS website. Two of the other removed links for "[Klondike Gold Rush National Historic Park](#)" and "[Yellowstone National Park](#)" led to live webpages as of December 20, 2017. The remaining three park names had not been linked since October 7, 2015 (See [List 1](#) for a list of all 97 park names and corresponding resources).
 - **Note:** No public NPS Web archive has yet been identified
3. Among the removed documents were climate action plans for prominent parks such as: "[Glacier National Park](#)", "[Everglades National Park](#)", "[Joshua Tree National Park](#)", and "[Grand Canyon National Park](#)". While EDGI has not yet spent substantial time analyzing the contents of these reports, many contain important research and policy determinations. For instance, the [Grand Canyon National Park plan](#) contains a section on reducing "park operations' energy use GHG emissions to 30 percent below 2008 levels by 2020" and another section exploring the likely impacts of different climate change scenarios, providing insight into the ways the park can improve its operations to mitigate climate change and adapt to its potential harms.
4. A note stating "If you would like to be emailed a copy of any listed park's action plan, please contact the NPS Sustainable Operations Branch: [e-mail us](#)" was added to the page (1.1b).
5. A link to a resource for NPS staff to learn more about becoming a CFP member and begin the membership process leads to an unavailable page (1.1a).

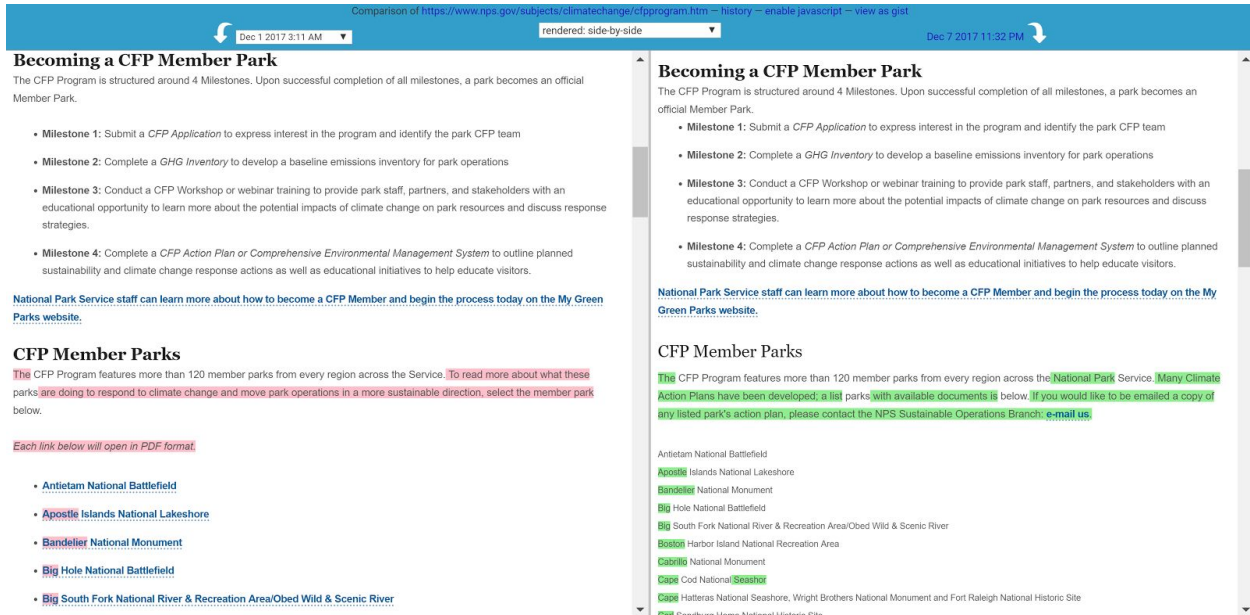

(1.1c) Removed links from all 97 park names in “CFP Member Parks” section (see [List 1](#))

- The following three park names “Indiana Dunes National Lakeshore”, “Minidoka National Historic Site”, “San Antonio Missions National Historic Park,” had no corresponding link as of [December 6, 2017](#). No linked documents were found for these three parks dating back to [October 7, 2015](#).
- Note: There are small typographical errors in the new, un-linked listing of parks.

² It is currently not possible to store a version of a page from the <https://mygreenparks.nps.gov/> domain in the Wayback Machine because it is not possible to access that domain’s IP address online at all, as it’s server does not exist or has been disconnected. It is unclear at this time if the domain has never been available or was previously available but either did not have pages from the domain stored within the Wayback Machine or had a script that prevented archiving of pages within the domain.

For each park, the list denotes the removed link URL, the corresponding document or webpage status, and the previous and current Internet Archive Wayback Machine (IAWM) records. Changes to the “Climate Friendly Parks Program” page prior to [December 6, 2017](#) have not been extensively analyzed. All document removals occurred between June 17, 2017 and December 20, 2017 - the dates of many of the removals definitively occurred in early December 2017 (a more extensive analysis to specify a narrower window of time for the removals has not been conducted):
